Airbrush Makeup- \$120/\$110

Traditional- \$100/\$90

Traditional makeup is applied by hand with tools such as a brush, beauty blender, or sponge, which can be worked into the skin for an even finish. The coverage of traditional makeup can range from a natural dewy glow to a matte-heavy or full coverage based on the formula. Traditional products such as powder, bronzer, and blush can be used in conjunction with a traditional foundation. Optional complimentary strip lashes are provided.

Service Count:

The final service count is due 30 days prior to your event date. Once the final service count has been received, services cannot be removed. Additional services may be added up to two weeks before your event; however, MOSS Salon & Spa must be notified to ensure that enough time and stylists are available to accommodate requests. The choice of add-ons will be at the discretion of the artist/stylists. We will do our best to accommodate your needs.

Payments:

Payments can be grouped together and paid in one lump sum or split individually per person on the day of services. We accept cash payments as well as Venmo. Credit card payments can be processed if other forms of payment are not available. Please note that gratuities are not included in the price of services as they are not mandatory but much appreciated. All trials and consultations are charged separately (\$100 per hour) and must be paid at the time of service. All trials are done at our salon location, 3546 Walters Rd., Syracuse, NY 13209. All retainers and payments are non-refundable.

Cancellation Policy & Consent:

Cancellations can be made at any time. However, cancellations made less than 60 days prior to your wedding will be subjected to a \$500 cancellation fee. In addition to forfeiting any and all retainers, deposits, and payments made. As we receive several inquiries throughout the year and dates fill up quickly, changes and cancellations within the contract can result in the salon losing available dates and opportunities to offer our services to others. If an artist or stylist cannot perform services for any reason, including but not limited to sickness, accident, weather, etc., reasonable accommodations shall be made or a full refund of the retainer, pre-payments, and/or deposits will be reimbursed. A credit card must be listed on file to guarantee your services. Your card will not be charged unless the contract is breached. By signing below, you give MOSS Salon & Spa permission to charge your credit card on file in the event of a cancellation without a 60-day notice. You acknowledge that you have read and understand this contract and that all questions have been answered by signing. By giving consent, you are choosing to hire MOSS Salon and Spa and its representatives for the services listed.
